# PRESENTER BIOS

#### Thomas Alphonso, Assistant Director of Policy and Procedure, U.S. Department of Veterans Affairs

Mr. Alphonso serves as the Assistant Director for Policy and Procedures in the Veterans Benefits Administration's Education Service. In this role, he oversees legislative implementation, regulatory amendment development, and policy and procedure formulation for all VA educational assistance benefits programs (commonly referred to as "GI Bill" programs).

He is a graduate of the United States Military Academy and served as an Army officer for six years in both the Infantry and Finance Corps. During his service, he was stationed at Fort Benning, GA; Fort Jackson, SC; and Yongsan Army Garrison, Republic of Korea.

Tom holds a B.S. in Philosophy and Literature from the United States Military Academy; an M.A. in Finance from Webster University; and a J.D. from Boston College Law School. He is currently an inactive member of the Massachusetts Bar and is a previous member of the New York Bar.

Tom currently lives in Washington, DC, with his wife, Meghan, who is a staff attorney with VA's Office of the General Counsel, Benefits Law Group, and his two daughters, Siobhan and Niamh. He is originally from Saint Bernard, LA, a suburb of New Orleans.

#### Ben Berck, CELO, Central Region, U.S. Department of Veterans Affairs

Ben Berck retired from the Air Force in 2008 after serving 24 years as a Ground Radar Technician and later as a Space and Missile Operations Officer. He began his VA career as an ELR and was promoted to Lead ELR, Supervisory ELR, and for the past 5 years served as the Chief Education Liaison Officer of the Central Region responsible for 11 states and 43 staff members.

#### Michael Criscuolo, Director, Connecticut State Approving Agency

Mr. Criscuolo began working at the Connecticut Office of Higher Education (OHE)/State Approving Agency (SAA) in February, 2010. As SAA Director, he is responsible for the approval and oversight of institutions and their programs so qualified veterans, and their dependents, may use their VA educational benefits at their school or training facility. His agency participates in outreach and career fairs throughout the year to promote the use of the GI Bill®.

Mr. Criscuolo served the National Association of State Approving Agencies (NASAA) as President. He has served NASAA as Vice President, Chair of the Communications Committee, Vice-Chair of the Professional Development Committee, Chair of the Conference Planning Committee, East Region Legislative Committee Representative, NASAA's East Region Vice-President, a member of the Compliance Survey Redesign Working Group, and as a representative on the Joint Advisory Committee, which was established to provide a standing forum for the resolution of issues related to the mutual responsibilities of the VA and SAAs for the effective administration of educational benefits to veterans and their dependents.

Locally, he serves as the Co-Chair of the Community Veterans Engagement Board and as a member of the Military & Veterans Support Coalition. In 2015, he was designated as the CT OHE's representative to serve on the Military Occupational Specialty Task Force, responsible for developing recommendations to improve the acceptance of military training towards licensure requirements and college credit.

#### Patrick Dworakowski, Ed.D. Assistant Director, Oversight & Accountability, U.S. Department of **Veterans Affairs**

Dr. Dworakowski joined the United States Department of Veterans Affairs (DoVA), VBA, Education Service as the Assistant Director, Oversight & Accountability after serving in multiple senior leadership positions in the Department of Defense and public education systems. Primary responsibility for the DoVA, Education is to Safeguard the Integrity of the GI Bill education benefits through the execution of Compliance, Enforcement, and Protection programming. The GI Bill distributes over \$12B annually to eligible beneficiaries attending approved education and training programs.

During service in the DoD Education Activity, his primary responsibilities were to strategically plan, direct, and coordinate PK-12 education initiatives and programs that supported 81,000 students across the world. As a DoD civilian voluntary deployment in support of Operation Enduring Freedom, he served as the Deputy Director, Development, International Security Assistance Force, HQ, Kabul, Afghanistan. Primary responsibilities focused on socio-economic development in collaboration with the Ministries of Education/Higher Education.

Dr. Dworakowski served multiple public education communities focused on children and families in both leadership and specialized positions: Chief Executive, Principal, Director, and Teacher. He also held parttime positions in higher education as an Adjunct Professor and Research Assistant.

Before completing his formal education, he spent seven years as an enlisted sailor in the United States Navy stationed aboard the U.S.S. John F. Kennedy (CV-67) as an aircraft director, firefighter, and training coordinator. Subsequently served at Naval Air Station Whiting Field supporting student aviators and leading a fire, crash, and rescue crew. He spent two deployments at sea including Operation Desert Shield and Storm and earned multiple decorations and awards during his service.

Dr. Dworakowski holds a Doctor of Education, Leadership, Duquesne University, Master of Science, Educational Administration, Franciscan University, and a Bachelor of Science in Education - Special Education, Slippery Rock University.

He is married and the proud father of two daughters and a son who reside in Northern Virginia.

#### Janice Fisher, Chief, Agreements & Federal Programs, U.S. Department of Veterans Affairs

Janice Fisher grew up in Niagara Falls, NY and received a Bachelor of Arts degree from State University of New York at Buffalo, Magna Cum Laude. She had an extensive Human Services career before beginning with VA at the Buffalo RPO as an Education Case Manager in 2001. Janice was promoted to Management and Program Analyst at VA Central Office in 2005 and moved to DC locality. She received a promotion to Chief, Contract Management Team in 2008 (name change of team to Agreements & Federal Programs several years ago). #### Larry Graves, Education Consultant, Wisconsin State Approving Agency

Larry Graves serves as an Education Consultant with the Wisconsin State Approving Agency. He is the chairperson for NASAA's IHL/NCD Committee and has recently led training presentations for the FY23 Risk-Based Compliance Survey model. Prior to joining the SAA in 2017, Larry spent 16 years working in public higher education, last serving as Registrar and Director of Admissions for the former University of Wisconsin Colleges. An Air Force veteran, Larry has a MS in Training & Organizational Development and BS in Technology Education from the University of Wisconsin-Stout.

#### Michelle Hill, NASAA President, Virginia State Approving Agency

Michelle Hill works as a Veterans Education Manager for the Virginia SAA and services as the current NASAA President. Prior to working for the Nevada and Virginia State Approving Agencies, she worked as a School Certifying Official with several Nevada schools and aided veterans and students with Title IV funding for over a decade. In addition, she worked in various management and supervisor roles within higher education. Her prior knowledge with VA education benefits and the inner workings of a school, allowed for a smooth transition in working for the SAA in July 2016.

In July 2021, Michelle relocated to Virginia where she was able to continue her work as part of the SAA team with the Virginia Department of Veteran Services. Throughout the years, she has continued to take an active role in serving those that have served our country and participating in many veterans' events taking any opportunity to share her knowledge of the VA Education benefit program.

Prior to her current NASAA role as President, Michelle served as Vice President, Communications Committee Chair, Military Education Chair, Vice-Chair of the Legislative Committee, and as a member of the Constitution and Bylaws, OJT/Apprenticeship, and Audit committees. #### Michael Marks, Chief, Approvals, Compliance & Liaison Team, U.S. Department of Veterans Affairs

Michael Marks is the Chief of Approvals Compliance and Liaison Division overseeing strategically planning, operational and tactical procedures to ensure proper oversight of approved education and training programs.

Michael has had a very successful career at the Veterans Administration since 1999 as a Claims Examiner in Education Division. He has moved through progressively more responsible positions to reach the current position he holds today. During his career, he has served as a Compliance Survey Specialist; Education Liaison Representative for various states; Coach for Education Services Unit and the Work Study Team. Previously, he served as the Chief Education Liaison Officer for the West Region Approvals, Compliance & Liaison Division.

#### Frank Myers, Assistant Director and Program Manager, South Carolina State Approving Agency

Frank Myers has worked for the South Carolina as the Program Manager and Assistant Director for the past 19 years. Frank graduated from Battery Creek High School located in Beaufort, South Carolina at the age of 17 and enlisted in the United States Army right after high school with his dad having to sign his enlistment papers. Thomas Palladino was selected as the Executive Director of the Texas Veterans Commission on October 1, 2010. In this position he is responsible for directing the overall administration of the agency and provides leadership for all stakeholders within the State of Texas to accomplish its mission which is to advocate for and provide superior service to veterans that will significantly improve the quality of life for all Texas Veterans, their Families, and their survivors. Tom Palladino is the most recent President of the National Association of State Directors of Veterans Affairs (NASDVA.)

He retired as a Colonel from the U.S. Army in September 2009 after 27 years of service (1982-2009). During this time Tom Palladino served in both the active U.S. Army and the Texas Army National Guard as an Active Guard Reserve officer.

As an Armored Cavalry Officer during the Cold War, he served in the 11th Armored Cavalry Regiment (Blackhorse) and patrolled the East-West Germany border in the Fulda Gap. He also served as an Armored Cavalry Troop Commander in the 3rd Armored Cavalry Regiment (Brave Rifles) at Ft. Bliss, Texas.

In the Texas Army National Guard, Tom Palladino served under the Adjutant General where he provided needed support and assistance to Texas National Guard Soldiers, Airmen, and military family members. He coordinated a state-wide collaborative partnership among all federal, state, and local organizations to enhance benefits and services for all military veterans and their families in the State of Texas.

He also served as an Associate Professor of Military Science (Army ROTC) at the University of Texas at Austin and an Associate Professor in Government at Austin Community College. As a Texas Public School Social Studies teacher, he taught High School and Middle School students in the Austin and Pflugerville Independent School Districts.

Tom Palladino's education includes a BA in Political Science from Providence College and a MA in Political Science from Southwest Texas State University, Texas. Additionally, he possesses a Texas Secondary Education Teaching Certificate and Texas Public School Principal's Certification.

#### Stephen Rudnick, State Approving Officer, Oklahoma State Approving Agency

Stephen Rudnick serves in the role of a State Approving Officer with the Oklahoma Department of Veterans Affairs State Approving Agency (ODVA SAA). Mr. Rudnick has served with ODVA SAA since it began operations in 2019 and served in the same capacity with the Oklahoma State Accrediting Agency (OKSAA) from 2017, until its sunset in 2019. During his time with ODVA SAA and OKSAA, Mr. Rudnick has strived to ease workloads, simplify challenging processes, and foster better communication between SAA, the VA, and the Veterans education community. Mr. Rudnick provides frequent training presentations to schools and professional organizations including Oklahoma Association of Student Financial Aid Administrators (OASFAA), Oklahoma Veteran Education Specialist Association (OVESA), National Association Of Veterans' Program Administrators (NAVPA) and others. Prior to his role in SAA, Mr. Rudnick was a School Certifying Official at the University of Oklahoma - Outreach, where he served students in online programs and at campuses worldwide. Mr. Rudnick brings with him broad experience in higher education, technology & trade, private enterprise, and volunteerism. He enjoys a scholarly interest in the laws, regulations, and the policies and procedures that govern the administration of VA education benefits. Mr. Rudnick prides himself in being part of a community of Veteran's Education Specialists and is dedicated to serving School Officials. When he isn't focused on VA Education, Mr. Rudnick spends his time providing a free youth archery program; being the PTA President's

first Gentlemen and Watch D.O.G.s coordinator at his children's school; volunteering at Kerr Scout Ranch; attending his children's dance and Special Olympics competitions; and napping.

#### James Ruhlman, Deputy Director of Program Management, U.S. Department of Veterans Affairs

James Ruhlman was appointed as the Deputy Director of Program Management within the Veterans Benefits Administration's Education Service in October 2017, and he has been a VA employee since July 2001.

James directs and monitors the activities within Education Service's Oversight & Accountability and Policy & Procedures portfolios. Prior to joining Education Service in 2007, he served in various positions at the Atlanta Regional Processing Office (RPO) including Education Case Manager, Senior Education Case Manager, and as RPO Training Coordinator.
