TATER TOT HOTDISH

Tater tot hotdish is considered the national dish of Minnesota. Tater tot hotdish usually consists of ground beef, cream of $___$ soup, some sort of veggies, and topped with tater tots.

LUTEFISK

Lutefisk is a traditional Scandinavian dish, particularly popular in Minnesota, made from dried cod that is soaked in lye and then rinsed and cooked





LEFSE

Lefse, a Norwegian flatbread, has a mild, slightly sweet, and buttery taste, with a hint of potato flavor, especially if made with potatoes. It's often compared to a soft tortilla or crêpe in texture, but with a more distinct potato and buttery flavor. It's a versatile flatbread that can be enjoyed with both sweet and savory toppings.

MANOOMIN

Manoomin porridge, also known as wild rice porridge, is a hearty breakfast staple, particularly popular in Minnesota where wild rice (or manoomin, in the Ojibwe language) is abundant. It is often made with cooked wild rice, cream or milk, maple syrup, and additions like dried fruit and nuts.


Gwen Hacker
